- ☐ You are a retired employee whose former position was directly or indirectly funded by the government of Manitoba, and you were a member of the MGEU, and you are receiving a pension from an employer / employee funded registered pension plan or registered retirement savings plan.

This application must be accompanied by documentation confirming that you are receiving periodic payments from a pension plan, such as a letter from your pension plan confirming your pension, a copy of a recent pension statement, or a copy of a recent T4 issued by your pension plan (your Proof of Pension).

Please be sure to redact personal and confidential information before submitting documents to MARGE.
