- You are a retired employee of an employer which participates in the Municipal Employees Pension Plan (the “MEPP”), and are receiving a pension or received a lump sum payment from the MEPP.
  
- You are a retired employee of the City of Winnipeg, and are receiving a pension or received a lump sum payment from the Winnipeg Civic Employees Pension Plan or the Winnipeg Police Pension Plan.

**Your application must be accompanied by documentation confirming your pension status such as a letter from your pension plan confirming your pension, a copy of a recent pension statement or a T4A issued by your pension plan (your Pension Document).** Please redact personal and confidential information before submitting such documents to MARGE.

### **Membership Fees**
